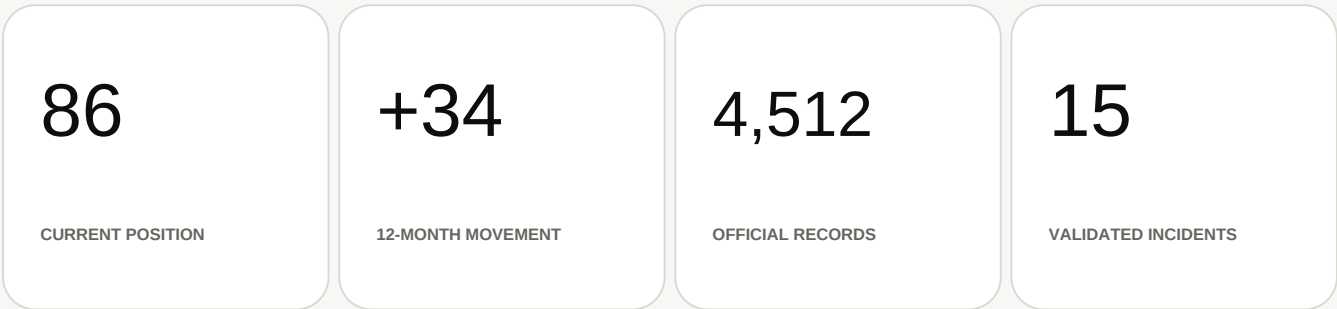

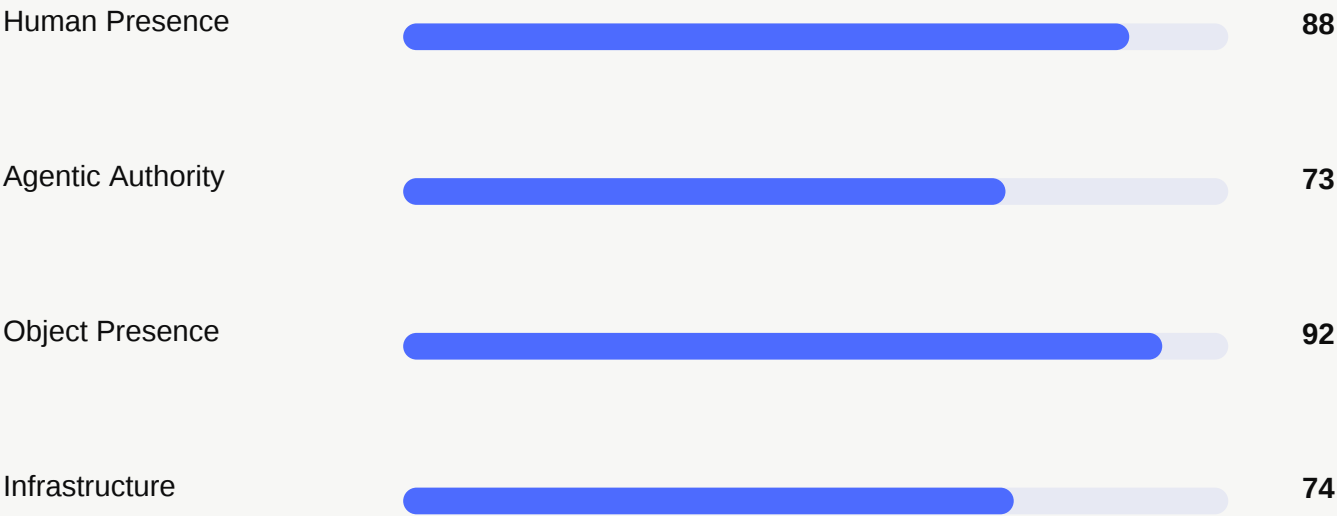

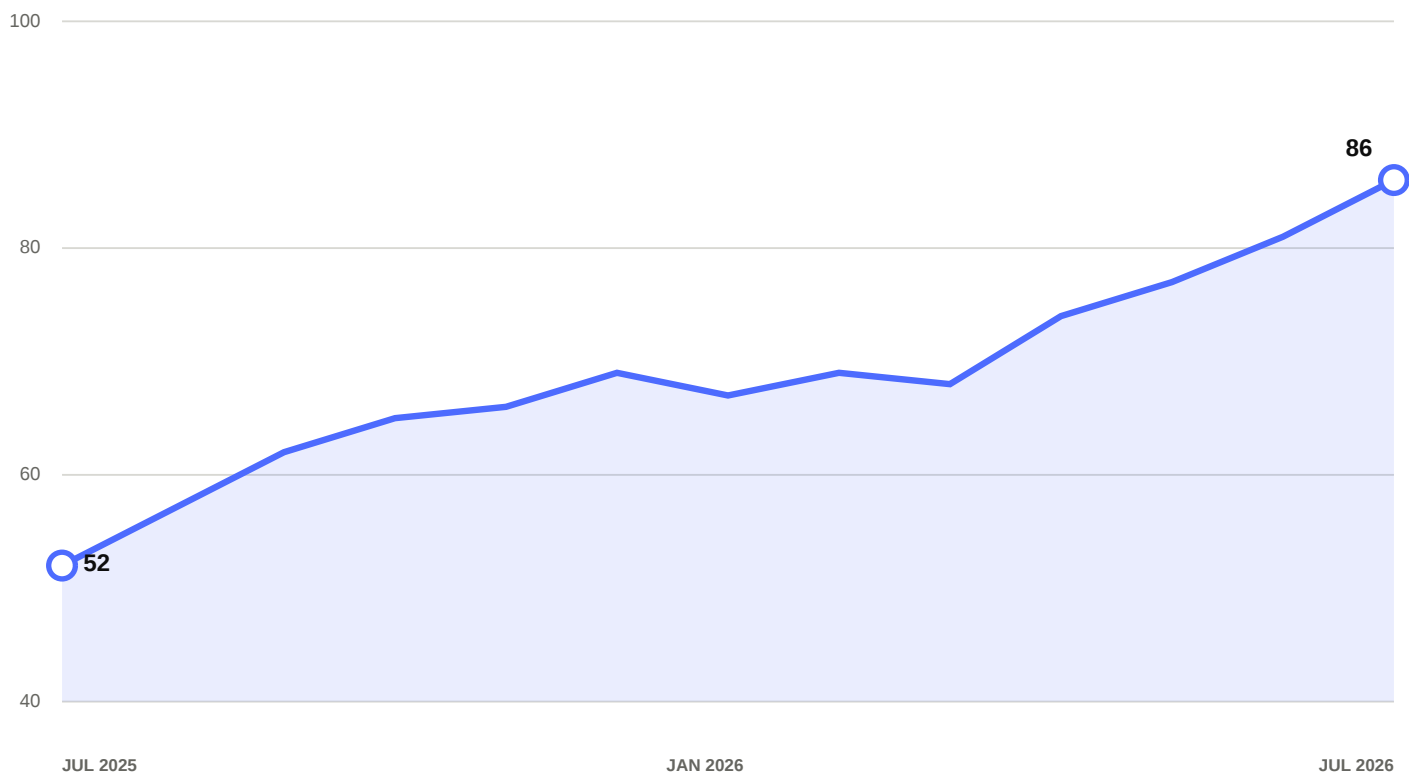
Object Presence

Pressure is highest where a listing, label or record can be accepted while the identity, condition or custody of the physical object remains unresolved.

The position is directional. It is not an incident probability, prevalence estimate, loss forecast or compliance rating.

Twelve months of *Presence pressure.*

The index rose from 52 to 86 across the published evidence window. Movement combines evidence density, authority depth, consequence and verification difficulty.



HOW TO READ THE LINE

Signal

Selected records and direct institutional sources move the evidence base.

Weight

Consequence, authority depth, exposure and verification difficulty shape the position.

Boundary

Unequal domain coverage prevents direct prevalence comparison across domains.

Signals with the highest *current editorial score.*

Each signal remains traceable to a direct or accountable source. The event score is an editorial indicator - not a probability.

THE INDEX DOES NOT CLAIM

- incident probability or predicted loss
- equal record coverage across domains
- independent forensic verification of every event
- a compliance, security or institutional performance rating

Digital validity is not *physical authority.*

Presence Risk is the exposure created when a consequential system accepts a valid-looking digital claim without establishing the expected person, object or accountable principal behind it.

Establish physical context.

Permit, deny, record or escalate.
